ENFORCEMENT OF JUDGMENTS AND ARBITRAL AWARDS

The Enforcement of Judgments Office (EJO) is a centralised unit for enforcing civil judgments related to the recovery of money, goods and property of the courts. The EJO can also enforce civil judgments made by other courts outside Northern Ireland, including England/Wales, Scotland and the European Union.

7.2 If a judgment debt or part of it is paid after the judgment creditor has applied to the High Court for a writ of execution or writ of control, paragraph 7.1 does not apply, and the judgment creditor must instead immediately notify the relevant enforcement officer in writing.

Briefing Note: Enforcement of a Judgment

Domestic law governs the enforceability and enforcement of foreign money judgments by Taiwan's courts without treaty influence or obligations, Article 402 of the Code of Civil Procedure sets out the substantive grounds for recognizing the validity of a judgment by a foreign court.

Taiwan - Enforcement of Money Judgments - Arbitration

A judgment for costs or expenses given in connection with the granting or refusal of recognition or enforcement of a decision may be enforced under this Convention only if the applicant in the proceedings for recognition or enforcement relied on this Convention.
